Job Profile Summary	Over the recent years the Global Fund has seen a significant increase in the proportion of its investments being dedicated to laboratory systems and diagnostic networks. The Medical Laboratory Specialist will contribute to maximizing effective use of the Global Fund investments to strengthen and improve laboratory systems and services. This effort is principally in support of HIV, TB, Malaria programs but also aims to strengthen lab systems more broadly and help countries achieve the objectives of the International Health Regulations (IHR 2005).

	Contribute to cross cutting work and support for laboratories during the grant life cycle: Work closely with disease teams in TAP to provide technical inputs on strengthening laboratory systems and services to Global Fund internal stakeholders including Grant Management Division (GMD) managers, country teams (CTs), Public Health & Monitoring and Evaluation (PHMEs), Health Product Managers (HPMs), Sourcing Operations, Private sector, Risk and the Resilient and Sustainable Systems for Health (RSSH) team
	Partnerships: Work with partners to support program implementation and ensures internal stakeholders are updated on technical advances related to diagnosis and treatment monitoring.
	Promote and Guide Innovations: Identify opportunities for expanding good laboratory practices and promoting new approaches and techniques that can help strengthen lab system performance.

	Under the leadership of the Head of RSSH and the Senior Medical Laboratory Specialist, the Medical Laboratory Specialist will work to ensure effective and efficient use of Global Fund resources for strengthening of laboratory systems and services and diagnostic products management for AIDS, TB and Malaria.

	Policy review and technical guidance: They will:
	Review and update existing technical guidance.

• Support the development of guidance for investments in laboratory systems strengthening.

- Identify opportunities to strengthen the Global Fund's contributions to health security within its mission and model.
- Help develop laboratory training materials for Country Teams and Health Product Management (HPM) Specialists and other internal stakeholders.

Provide advice and support during the entire grant life cycle (Funding request development, Grant making and implementation): They will:

- · Work closely with diseases teams to provide technical expertise to country teams throughout the grant life cycle
- Work closely with Supply Operations and advise on appropriate procurement of laboratory commodities and equipment considering options for integration of services.
- Monitor scientific and programmatic developments, including new diagnostic tools and supports appropriate dissemination, training and technical capacity building across the Global Fund

Review and Analysis of laboratory systems: They will provide professional opinion and expert guidance to HPM Specialists and Country Teams on:

- Adequacy of the proposed investments in laboratory equipment, systems strengthening, opportunities for integration, and expansion.
- · Identify best practices and lessons learnt in Global Fund grants related to laboratory services and health security
- Recognize and act on opportunities for South-to-South Learning and Technical Assistance (TA)
- · Review forecasts and quantification of laboratory supplies requirements.

Partnerships: They will work with key technical and funding partners to ensure harmonization of technical support and alignment to National Lab Strategies, implementation plans, and Global Fund grants. Perform other relevant duties as required by the Senior Medical Laboratory Specialist.
